

We hereby further confirm that there are no material reasons other than the reasons specified in the resignation letter received from Ms. Bela Desai enclosed as **Annexure II**.

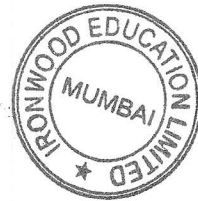


Dear Board Members,
